Sub:Temporary absorption of Class XII students of CST Kalimpong and CST Darjeeling in CST, Mussoorie ,CST-Herbertpur and CST-Shimla on due to unrest in the State of West Bengal.

Sir,

In response to your letter No. 3-DL(2)2017 /2018/DoE-333 dated 24.7.2017 on the subject cited above it is to inform that considering the situation of Darjeeling and need of students of class XII , the administration has considered the request and agreed for temporary shifting of class XII students of CST Kalimpong and CST Darjeeling. Accordingly following directions are given to concerned schools:


- A.(i)All the students of class XII ( Commerce & Science) of CST Kalimpong and CST Darjeeling will be absorbed in CST Mussoorie with effect from 7<sup>th</sup> Aug.,2017 and they will be accommodated in the hostels.
- (ii) Students of class XII (Arts) of CST Kalimpong and Darjeeling will be absorbed in CST Herbertpur and arrangement of hostel facility will be done by DOE, CTA Dharamsala.
- iii) Students of class XII ( Hospitality Education ) of CST Darjeeling will be absorbed in CST Shimla w.e.f. 7<sup>th</sup> Aug.,2017 and will be accommodated in Hostel.
- B. Expenses of transportation of students for both to and from may be borne by the parents and safe arrival of students to CST Mussoorie, Herbertpur and Shimla are to be ensured by the School heads and parents under guidance of DoE ,CTA,Dharamsala.
- C. The above boarders will be accommodated in CST Mussoorie, Herbertpur and Shimla on existing terms & conditions . Reimbursement of boarding fee will be done by DOE & CTSA as they were providing in existing schools. The CTSA part will be reimbursed by the concerned school.
- D.(i)Day scholars of CST Kalimpong and CST Darjeeling for the time being will be treated as boarders of CST, Mussoorie , Herbertpur and Shimla according to streams and boarding expenses will be borne by the DOE, CTA.Dharamsala. TA will be borne by parents / DOE,Dharamsala.
- (ii) On the willingness of the parents of the Indian students of CST Kalimpong and CST Darjeeling for the time being, they will be treated as boarders of CST Mussoorie, Herberput and Shimla according to streams and boarding expenses will be borne by the DOE, CTA,Dharamsala. TA will be borne by parents or DOE,Dharamsala.

E. Any additional subject teachers and Warden ,Matron on the requirement may be temporarily attached from CST Kalimpong and CST Darjeeling by CTSA as per rules.

F. Registration for CBSE Board examination for these students may be done from CST Mussoorie,Herbertpur & Shimla, if the unrest situation in the West Bengal state remains unresolved till filling of Board Examination form.
