Member Secretary briefed the Governing Body that, due to objection from the Municipal Corporation Office, the Gangtok School Property, which was to be renovated on the initial investment by a retired government contractor, Mr. Tashi Dawa, could not take place. Therefore, after much deliberation the members advised that Society should again find out the possibility of selling the property among CTA Departments at a nominal price for the welfare projects of the Tibetan community. If the Society didn't find any possible buyers within CTA then the Department of Education could advertise the sale of the property at negotiable price within Tibetans and Tibetan descendants' community.
- 2. The members advised that, since the TCEWF has been reregistered in conformity with the provision of the H.P. Societies Registration Act, 2006, the Society should also follow its rule by constituting General Body, like Finance Committee, as per the Clause No. 9(a) of the Rules. Therefore, it was unanimously approved to set up General Body comprising of Section Heads and senior officers of DoE.

The meeting concluded with vote of thanks to the Chairman and members of the Governing Body.
