### ITEM NO. 7: Any other matter with the permission of the Chair

#### Resolution:

- The Sambhota Tibetan School in Bhuntar was converted into the Centre for Teacher Education Bhuntar (CTE Bhuntar) in 2012, operating as a branch of the Central University of Tibetan Studies (CUTS) Sarnath. But subsequently in 2019 it was closed down and renamed as CTE-CIHTS. Following the closure of the CTE Bhutar, the 15th Kashag handed over the possession of the CTE Bhuntar from TCEWF to the Central Tibetan Relief Committee (CTRC) of Home Department, CTA. However, the security deposit of electricity connection of the campus remain with the TCEWF. Therefore, the Board has deemed it necessary to get the refund of security deposit from the HP Electricity Board in consultation with CTRC of Home Department.
- Owing to a continuous decrease in student enrolment, the Tibetan Children's Educational Welfare Fund (TCEWF) was compelled to close down the Thonsam School located in Sichey, Gangtok, Sikkim in 2014. However, in the interest of society, the Board Members have resolved to sell the land, along with any buildings constructed thereon. During the 51<sup>st</sup> GB meeting of TCEWF, the Board Members discussed to propose the aforementioned property to the Central Tibetan Relief Committee of Home Department for the housing project of Tibetan refugees from Lachen and Lachung.
